The Company would like to inform its shareholders and investors that, as a result of the completion of the share transfer between Zentiva N.V. (100% owned and controlled subsidiary of Sanofi Aventis



Europe), as seller and AI Sirona BidCo s.r.o. (100% owned and controlled by AI Sirona (Luxembourg) Acquisition S. à r.l., a company that is entirely owned by AI Sirona (Luxembourg) Subco S. à r.l. and ultimately controlled by Advent Funds GPE VIII, a fund managed by Advent International Corporation, as purchaser, the control over Zentiva Group a.s., the majority shareholder of the Company (holding 388,730,877 shares, representing 93.2295% of the Company's share capital and voting rights) has been transferred. Consequently, an indirect change of control over the Company has occurred following the transfer described above.

According to the disclosure, as of 30 September 2018, the indirect holdings of Zentiva N.V. in the Company were reduced from 388,730,877 shares, representing 93.2295% of the Company's share capital and voting rights to zero (0) shares and voting rights. The indirect holdings of AI Sirona BidCo s.r.o. in the Company increased from zero (0) shares and votings rights to 388,730,877 shares, representing 93.2295% of the Company's share capital and voting rights.

The disclosure of holdings of both Zentiva N.V. and AI Sirona BidCo s.r.o. are attached as Annex to this report.
