ZENTIVA S.A. reports 1st Quarter 2017 turnover of 110.3 MRON, 10% higher compared to 1st Quarter 2016, and an operating profit of 22.6 MRON.

Operational profit is 9% lower compared to previous year mainly due to increase of claw back tax, merchandises mix and favorable impact in 2016 from price negotiation, with the impact on the reversal of provision in Q1 2016, for raw material floating price.
